## We educate ourselves

We follow the science. In a time of crisis without clear national guidance, we turn to vetted experts to decide what are best practices for risk mitigation.

Design Thinking means that listening to our “users” -- students, families, and teachers -- is front and center. Our summer is designed to make sure that stakeholder voices are heard. Parents, teachers, and even students must be allowed to express their concerns. Surveys, empathy mapping, and frequent conversations are part of our collection tools.

## We collaborate

Each member of staff is collaborating with other professionals in their field in this time of Zoom. We know what we don't know, and are working with those members of our community with expertise in certain areas. Our professional organizations -- AISGW, NAIS, NAES, AIMS, and more -- all provide guidance and resources.

# Is it safe to be in person?

The Grace team and task forces have been following recommendations from various bodies and believe *at this time* and while we are in Phase 2 of reopening in Montgomery County that we can accomplish a healthy, in-person **outdoor** experience this fall. Choosing this as a family is optional.

Why?

1. In-person school is especially critical for the early childhood and elementary ages we serve.
2. We are small in population and our campus -- inside and outside -- is vast. This works to our advantage in complying with best practices for healthy schools.

# Distance Learning Growth



- \* Changes for the fall will include Seesaw as our platform and a school-wide schedule of Zoom meeting anchor points (such as daily Morning Meeting).
- \* Consistency across classrooms and within the Seesaw platform will be key to providing a quality program for our families.
- \* To promote community connection and offer deeper activity and outdoor time, we hope to offer each class one day a week on campus to enjoy our outdoor space.

- \* The next Head of School call is set for Wednesday, August 12. We will offer two sessions at 12 pm and 7 pm.
- \* We will have more to share about which days will be designated for each grade to be on campus and all of the health and safety protocols associated with those days. We will also say more about our plans for Preschool and PreK which may differ from the rest of the school program.
